#### Additional Information

A non-refundable Registration Fee of £30.00 is required to secure your place.

Fees include all meals and snacks prepared onsite by our chef. Our menus have been awarded the Quality Mark by the Early Years Alliance.

The nursery is open 51 weeks of the year, closing for a week at Christmas and all other Bank/Public holidays (chargeable).

No refund is given for non-attendance for holiday and sickness.

A 5% sibling discount is available subject to T&Cs.

Fees are payable one month in advance through the Family App by Tax-Free Childcare/Direct Debit/Debit Card/Credit Card or by Childcare Vouchers.

Late collection will incur an additional surcharge of £8.55 per 15 minutes.

We do not provide childcare by the hour.

## Early Years Education Entitlement



Children aged 9 months to 4 years old of eligible working families are entitled to 30 hours of early years education for 38 weeks or stretched for the equivalent number of hours across more weeks per year.

Children will qualify for an education entitlement place the term after their child turns 9 months old.

Visit the [Childcare Choices](#) website to find out if you are eligible.

To meet the needs of working families and provide continuity of care for our children, we stretch the government funded hours over the 51 weeks of the year we are open. This means that a working parent eligible for 30 hours funding per week, over 38 weeks, can access 22 hours over 51 weeks.

**Your Early Years Education Entitlement hours will be allocated to full day sessions first.**

**As our sessions are either 5 or 10 hours long, you will have 2 residual government funded hours left to use against another 5 or 10-hour session (that is part of your permanent booking pattern).**

**Any hours over and above the funded hours will be charged at the nursery standard hourly rate, as detailed below:**

The Government funding is intended to cover the Early Years Foundation Stage basic provision only and is not intended to cover the costs of meals, other consumables, additional hours or additional services.

**We therefore charge the following for the extras not covered by the government funding:**

Any parent wishing to opt out of these additional charges should speak to their Nursery Manager who will explain the process and provide the necessary policies which must be adhered to.

## Additional Information

One months' notice is required to opt out of any additional charges for the following term.

No changes can be made during a term.

At any time, if a parent does not adhere to the correct policy of providing alternatives for the additional charges, Happy Days will charge the parent for any additional activities, food or services accessed, in accordance with the fee sheet.

The additional charges apply to all sessions booked. As per our terms and conditions, no refund will be given in the event of the child's absence due to illness, holiday or for any other reason.

Parents must sign the Early Years Education Entitlement Parent Contract to access their funded sessions.

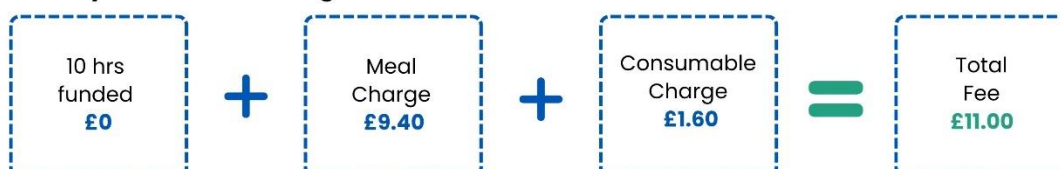

Based on a child under 2 years old

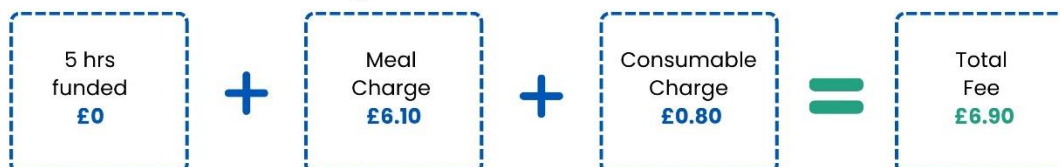
### Full Day with 10 hrs funding
